## What are the Psychology Board's goals?

### VISION

 A competent and flexible psychology workforce that meets the current and future needs of the Australian community

### MISSION

- To regulate psychologists in the public interest
- Key issues: international standards and mobility; accreditation standards; safe, ethical practice



# Drivers of change

- 1. Public consumers of psychology services
- 2. Universities priority-setting, staffing choices, funding arrangements, curriculum choices
- 3. Professional societies advocacy and lobbying
- 4. Governments opportunities for workforce reform and funding of public priorities
- 5. Employers budgets to fund workforce and value-formoney arrangements
- 6. Accreditation agency quality and integrity of programs of study while encouraging flexibility
- 7. Regulatory agency standards for public safety
- 8. International recognition and mobility

### Five key mandatory obligations

- 1. Mandatory criminal history and identity checks
- 2. Mandatory continuing professional development
- 3. Mandatory professional indemnity insurance
- 4. Handling of notifications and complaints
  - 1. Health, performance and conduct matters
  - 2. Mandatory reporting of serious misconduct or impairment
- 5. English language standard



### Key features

- Protection of the public, APS code of ethics
- Protection of title, advertising standards
- Scheme self-funded through single national, profession-specific registration fee
- Independence of accreditation of higher education and training providers
- Informal terminology: PsyBA (Psychology Board of Australia) – not in writing
- 30 November psychologist re-registration date



### Key facts

- 560,000 health practitioners in Australia
- 1 person in 40 is a health professional
- Psychology is third largest profession
- Global shortage of health practitioners
- Ageing population, living longer
- Migration of the health workforce (for example, 70% of all psychiatrists in NZ are overseas-trained)

- 29% of all general registrants

Note - The location classifications are according to ARIA+ Codes worked out on a scale from 0-15 as follows:

0 - 0.10 Metropolitan and major cities (i.e. Canberra ACT, Fremantle WA, Bondi NSW)

>0.10 - 0.25 Outer suburban and large regional cities (i.e. Geelong Vic, Robina Qld, Wollongong NSW)

>0.25 - 2.40 Outlying suburban, regional areas and towns (i.e. Aldinga Beach SA, Launceston Tas, Melton Vic)

>2.40 - 5.92 Outer regional (i.e. Coffs Harbour NSW, Mildura Vic, Margaret River WA)

>5.92 - 15.00 Remote (i.e. Alice Springs NT, King Island Tas, Mt Isa Qld)



### Current trends...

- Clinical psychology is the standard area of practice endorsement, and is recognised by governments in industrial awards, Medicare rebates, medico-legal bodies, is well represented across universities and is driven by student demand
- 10% have an additional AoPE 78% have clinical
- Rethink of route to other AoPE accredited courses, supervision, professional development plus structured oral and written exams

### Board's current priorities...

- National Psychology Examination
- Supervisor training and certification
- Development of 5+1 programs
- Revision of 4+2 programs
- Area of practice and specialisations sustainability and public interest
- Accreditation review and the international developments...



### Full Registration = 6-year sequence Endorsement = 8-year sequence





### National Psychology Examination

- Sit in the 6<sup>th</sup> year of the 4+2 or 5+1 programs
- 3-hour multiple choice
- 4 domains ethics, assessment, intervention, communication
- Case study-based questions
- Acceptable to re-sit exam if failed

### National Psychology Examination

- Examinations will run about 4 times a year in 8 confidential, secure test centres across Australia
- Cost will likely be below \$500
- Starts 1 July 2013 transition provision will allow one more year of grace, i.e. those applying for general registration before 1 July 2014 do not need to sit exam
- Candidates will be able to fail up to 3 times before needing to do further internship work
- Sit the exam at any time in 6<sup>th</sup> (final) year



### Supervisors and supervisor training

- The Board's approach
  - Supervision is critical
  - QLD is the model
  - Quality training for supervisors (competency-based, best practice)
  - Quality supervisors for the four training pathways (4+2, 5+1, Masters, Registrar)
  - Training for regional areas a priority
- Where things are up to
  - Over 6000 supervisors now listed on website
  - Board has held two consultations
  - Guidelines being finalised
  - 'Request for proposal' process being developed



Before 1 July 2013, grandfathering provisions to become Board-approved supervisor From 1 July 2013, new supervisors will need to have done approved supervisor training University supervisors of fieldwork practicums must be Board-approved

# Q: are there exemptions or reductions in CPD for special circumstances?

- A: Yes. The person must get written approval for exemptions in advance by writing to the Board. Exemptions are calculated at 2.5 hours/month.
  - An example is when a psychologist goes on maternity leave.
  - In general there are no exemptions for those in part-time practice.



### Communication

- National Board meets once a month
- After each meeting Board has issued a communiqué of key decisions and activities
