

Communiqué

28 March 2014

The Psychology Board of Australia (the Board) is established under the Health Practitioner Regulation National Law, as in force in each state and territory (the National Law). This communiqué highlights key issues from the 50th meeting of the Board on 28 March 2014. At each meeting, the Board considers a wide range of issues, many of which are routine and are not included in this communiqué.

First all Boards meeting - National and Regional Boards Retreat

The Board hosted its first all board meeting – the National and Regional Boards Retreat – on 26 and 27 March 2014 in Sydney. All national and regional board members participated, along with members of the Psychology Council of NSW and senior AHPRA staff.

The retreat focused on the work of the national and regional boards of the Psychology Board of Australia in regulating the psychology profession. The retreat provided an opportunity to reflect on the Board's role, approach to regulation, and key relationships with regional and national partners and the broader context of psychology and the community. The retreat also presented an opportunity to meet and discuss the challenges of the coming year.

Participants heard from AHPRA CEO Martin Fletcher on organisational redesign, General Counsel Dominique Saunders on the principles of regulation, and Director, National Boards Services, Chris Robertson on the intergovernmental landscape. The retreat also allowed participants an opportunity to reflect upon the history of regulation and international developments likely to occur over the next 20 years in international mobility and regulatory agreements and processes.

Advertising guidelines: update

Revised *Advertising guidelines* came into effect on 17 March. These are published under *Codes and guidelines* on the Board's website.

The guidelines were developed by the National Boards and explain the requirements of the Health Practitioner Regulation National Law, as in force in each state and territory (National Law) in relation to advertising and the use of testimonials in advertising. The National Law does not allow testimonials to be used when advertising a regulated health service (section 133). A fact sheet has been developed, and revisions to the guidelines is currently being considered to clarify issues with testimonials. As stated in the fact sheet, practitioners are not responsible for removing (or trying to have removed) unsolicited testimonials published on a website or in social media over which they do not have control.

Consultation update

Shortly, the Board will begin public consultation on its general, continuing professional development (CPD) and recency of practice registration standards, and associated guidelines and policies.

Consultation is an important part of the Board's engagement with psychologists and members of the public. Feedback received is greatly valued, and informs the Board's development of registration standards, codes, and guidelines.

Accreditation of programs

Under section 49 of the National Law, the Board requires accreditation reports from the Australian Psychology Accreditation Council (APAC) before it can approve the accredited programs of study as providing a qualification for the purposes of registration.
